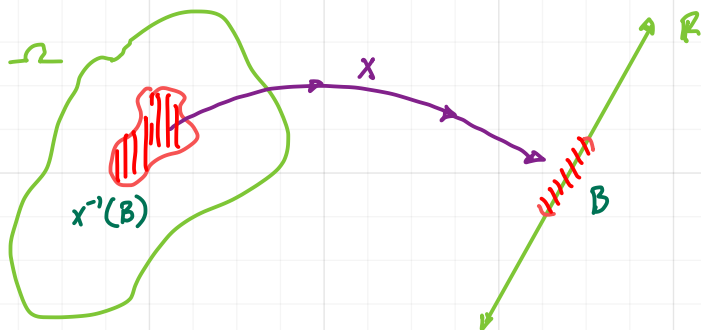
P $\longleftrightarrow$ CAT measure

$\star$
r.v. X $\longleftrightarrow$ Measurable function (PAM)
"random experiment"

Defn: $X: \Omega \rightarrow \mathbb{R}$ is a random variable (r.v.)
on $(\Omega, \mathcal{Q})$

iff PAM: Pullbacks are Always Measurable

iff $\forall B \in \mathcal{B}(\mathbb{R}): X^{-1}(B) \in \mathcal{Q}$.



$\therefore P(X^{-1}(B))$ defined if $X^{-1}(B) \in \mathcal{Q}$ since
since $P: \mathcal{Q} \rightarrow [0, 1]$

Ex: ^{*} (Indicator function) $I_A: \Omega \rightarrow \{0,1\}$.

with $A \subset \Omega$ and $A \in \mathcal{Q}$. Define

$$I_A(\omega) = \begin{cases} 1 & \text{if } \omega \in A. \\ 0 & \text{if } \omega \notin A. \end{cases}$$

$$\therefore I_A^{-1}(\{0\}) = A^c \in \mathcal{Q} \quad (\text{by CRT})$$

$$I_A^{-1}(\{1\}) = A \in \mathcal{Q}$$

$\therefore I_A$ is a r.v. (is "measurable")

Ex: PAM can fail. Define $\Omega = [0,10]$

$$\mathcal{Q} = \{\emptyset, [0,3], [3,10], \Omega\}.$$

$$X: \Omega \rightarrow \Omega$$

$$X(\omega) = \omega \quad \text{if } \omega \in \Omega \quad (\text{identity function})$$

Range S.A. $\mathcal{B}([0,10])$

$$\text{pick } B = (2,4) \in \mathcal{B}([0,10])$$

$$\therefore X^{-1}(B) = X^{-1}((2,4)) = (2,4) \notin \mathcal{Q}.$$

$\therefore X$ is NOT a r.v. (PAM fails)

Defn: Cumulative Distribution Function (CDF)

Say $X: \Omega \rightarrow \mathbb{R}$ is a r.v. on p.s. $(\Omega, \mathcal{A}, P)$.

$$\begin{aligned}\text{Then CDF } F_x(\cdot) &\triangleq P(X \leq x) \\ &= P(\{\omega \in \Omega : X(\omega) \leq x\}) \\ &= P(X^{-1}((-\infty, x]))\end{aligned}$$

Note: CDF F_x always exists.

Defn: $f: \mathbb{R} \rightarrow \mathbb{R}$ is continuous at $x_0 \in \mathbb{R}$

iff $\forall \epsilon > 0 \exists \delta > 0: |x - x_0| < \delta \rightarrow |f(x) - f(x_0)| < \epsilon$.

Defn: f is continuous iff it is continuous at $\forall x_0 \in \mathbb{R}$.

Reminder: $\exists x \forall y \longrightarrow \forall y \exists x$

Defn: f is uniformly continuous on $S \subset \mathbb{R}$ iff.

$$\forall \varepsilon > 0 \exists \delta > 0 : \forall x \in S \forall z \in S, |x - z| < \delta \longrightarrow |f(x) - f(z)| < \varepsilon.$$

Fact: uniform continuity $\longrightarrow$ continuity

Fact: $f: [a, b] \longrightarrow \mathbb{R}$ is uniformly continuous

closed and bounded ("compact"): f is continuous

Defn: CDF $F: \mathbb{R} \longrightarrow [0, 1]$ is absolutely continuous

iff $\forall \varepsilon > 0 \exists \delta > 0 : \forall$ finite set $[a_i, b_i] \ i=1, \dots, k$
of non-overlapping intervals

$$\sum_{i=1}^k (b_i - a_i) < \delta \longrightarrow \sum_{i=1}^k |F(b_i) - F(a_i)| < \varepsilon.$$

★

Thm: CDF F is absolutely continuous iff $\exists$
probability density function (pdf) f :

$$F(x) = \int_{-\infty}^x f(t) dt.$$

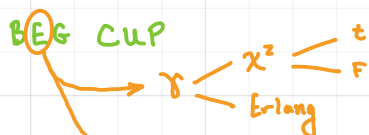
$$\therefore \textcircled{1} f = F' = \frac{dF}{dx}$$

$$\textcircled{2} \int_{-\infty}^{\infty} f(x) dx = 1$$

BEG CUP → Exponential pdf.

$$X \sim \exp(\Theta): f(x) = \frac{1}{\Theta} \cdot e^{-x/\Theta} \quad \text{if } x > 0, \Theta > 0.$$

BEG CUP



Extreme Value pdfs (EV).

• Weibull

• Frechet

• Gumbel

} $\max(X_1, \dots, X_n)$
E.V. theorem (Fisher-Tippets)

Gamma pdf:

$$X \sim \gamma(\alpha, \Theta) \quad x > 0, \alpha > 0, \Theta > 0$$

$$f_X(x) = \frac{x^{\alpha-1} e^{-x/\Theta}}{\Gamma(\alpha) \cdot \Theta^\alpha}$$

$$\Gamma(\alpha) = \int_0^\infty x^{\alpha-1} e^{-x} dx.$$

∴ 3-special cases

① $\alpha = 1 \longrightarrow$ Exponential ("waiting time")

② $\alpha \in \mathbb{Z}^+ \longrightarrow$ Erlang

③ $\alpha = \frac{r}{2}, \Theta = 2 \longrightarrow X \sim \chi^2(r)$

$r \in \mathbb{Z}^+$

for "r degrees of freedom"

E.V. pdfs

- $X \sim \text{Weibull}(k, \theta)$ CDF: $F_X(x) = 1 - e^{-(x/\theta)^k}$ $k > 0, x > 0$

$\therefore k=1 \longrightarrow X \sim \text{Exp}(\theta)$

(also: Rayleigh)

- $X \sim \text{Gumbel}(m, d)$
location scale

$$F_X(x) = e^{-e^{-(\frac{x-m}{d})}}$$

$x \in \mathbb{R}$

- $X \sim \text{Fréchet}(m, d)$

$$F_X(x) = e^{-(\frac{x-m}{d})^\alpha}$$

$x > m$
 $\alpha > 0$

“shape”

BEG CUP $\longrightarrow$ Uniform pdf

$X \sim U[a, b]: f_X(x) = \frac{1}{b-a}$ if $x \in [a, b]$, else = 0.

$\therefore$ CDF is a “ramp”



$X \sim \text{Beta}(\alpha, \beta): f_X(x) = \frac{\Gamma(\alpha+\beta)}{\Gamma(\alpha)\Gamma(\beta)} \cdot x^{\alpha-1} (1-x)^{\beta-1}$

if $0 < x < 1$ (else = 0)

$\therefore \alpha = \beta = 1 \longrightarrow X \sim U[0, 1]$.

(n-dim, Dirichlet pdf)

(Normal pdf)

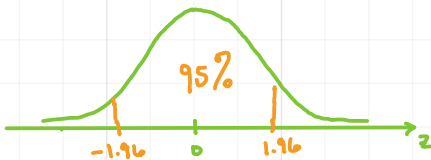
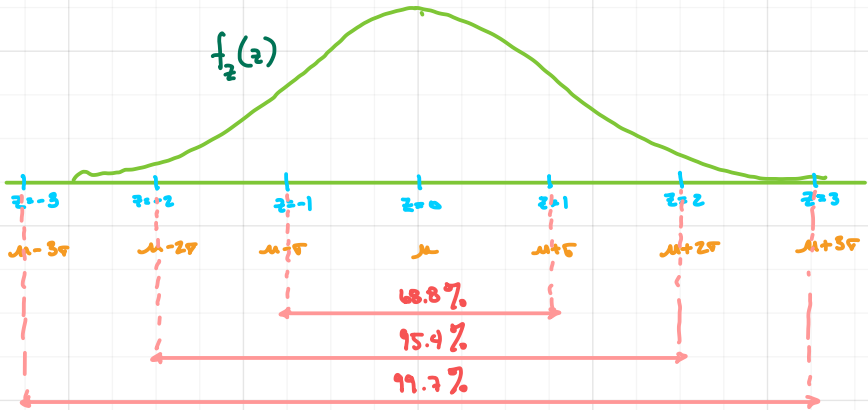
$$X \sim N(\mu, \sigma^2) : f_X(x) = \frac{1}{\sqrt{2\pi}\sigma} e^{-\frac{1}{2}\left(\frac{x-\mu}{\sigma}\right)^2}$$

$\mu \in \mathbb{R}$
 $\sigma > 0$
 $x \in \mathbb{R}$

Standard Normal:

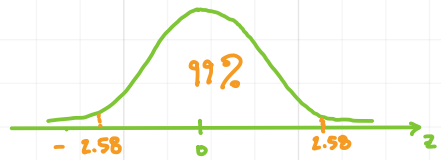
$$Z \sim N(0, 1) : f_Z(z) = \frac{1}{\sqrt{2\pi}} e^{-z^2/2}$$

$z = \frac{x - \mu}{\sigma}$
standardize



$$95\% \leftrightarrow z = \pm 1.96$$

($\hat{z} \pm 2\sigma$)



$$99\% \leftrightarrow z = \pm 2.58$$

Gaussian integral

$$\int_{-\infty}^{\infty} e^{-x^2} dx = \sqrt{\pi}$$

Prf: $\int_{-\infty}^{\infty} e^{-x^2} dx = \sqrt{\left(\int_{-\infty}^{\infty} e^{-x^2} dx\right)\left(\int_{-\infty}^{\infty} e^{-y^2} dy\right)} = \sqrt{\int_{-\infty}^{\infty} \int_{-\infty}^{\infty} e^{-(x^2+y^2)} dx dy}$

polar

$$= \sqrt{\int_{\theta=0}^{2\pi} \int_{r=0}^{\infty} r e^{-r^2} dr d\theta}$$

$$dx dy \mapsto r \cdot dr d\theta$$

$$= \sqrt{2\pi \cdot \int_0^{\infty} r \cdot e^{-r^2} dr} = \sqrt{2\pi} \cdot \sqrt{\frac{1}{2}} = \sqrt{\pi}$$

QED.

$$\therefore \sqrt{\pi} = \int_{-\infty}^{\infty} e^{-x^2} dx \stackrel{\text{even}}{=} 2 \int_0^{\infty} e^{-x^2} dx$$

$$\text{put } x = \sqrt{u} = u^{1/2}$$

$$\therefore dx = \frac{1}{2} u^{-1/2} du$$

$$\therefore x=0 \rightarrow u=0$$

$$x=\infty \rightarrow u=\infty$$

$$= 2 \int_{u=0}^{u=\infty} e^{-u} \cdot \frac{1}{2} u^{-1/2} du$$

$$= \int_0^{\infty} u^{\frac{1}{2}-1} e^{-u} du = \Gamma\left(\frac{1}{2}\right)$$

$$\therefore \Gamma\left(\frac{1}{2}\right) = \sqrt{\pi}$$

Normal Table Values

$$X \sim N(\mu, \sigma^2)$$

$$\text{CDF: } F_X(x) = \int_{-\infty}^x f(w) dw$$

$$= \frac{1}{\sigma\sqrt{2\pi}} \cdot \int_{-\infty}^x e^{-\frac{1}{2}\left(\frac{w-\mu}{\sigma}\right)^2} dw$$

no closed form $\rightarrow$

$$Z \sim N(0, 1)$$

$$\Phi(z) = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^z e^{-w^2/2} dw$$

$\therefore$ use table

$$\text{Symmetry: } \Phi(-z) = 1 - \Phi(z)$$



Note: Q-function

$$Q(x) = 1 - \Phi(x) = P(Z > x)$$

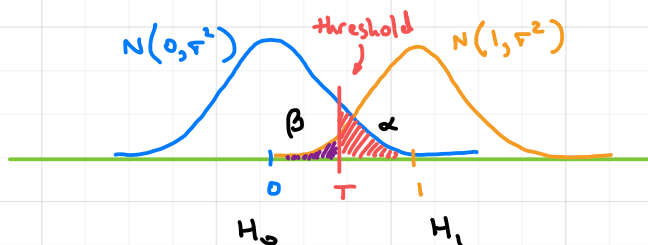
$$= \frac{1}{2} - \frac{1}{2} \operatorname{erf}\left(\frac{x}{\sqrt{2}}\right)$$

for "error function" $\operatorname{erf}(x) \triangleq \frac{2}{\sqrt{\pi}} \int_0^x e^{-w^2} dw$

Signal Detection



$$H_0: \text{no signal} \quad X \sim N(0, \sigma^2)$$

$$H_a: \text{signal present} \quad X \sim N(1, \sigma^2)$$

decision rule

$$H_0 \text{ if } X \leq T$$

$$H_1 \text{ if } X > T$$

$$\alpha \triangleq P[\text{Type 1 error}] = P[\text{reject } H_0 \mid H_0 \text{ true}].$$

$$= P[X > T \mid H_0]$$

$$= P[\text{false alarm}] \quad \text{false positive}$$

$$\therefore 1 - \alpha = P[\text{correct rejection}].$$

$$\beta \triangleq P[\text{Type 2 error}] = P[\text{accept } H_0 \mid H_a \text{ true}].$$

$$= P[X \leq T \mid H_a]$$

$$P[X > T \mid H_a] = P[\text{miss}]$$

false negative

$$\therefore \text{"Power"} \triangleq 1 - \beta = P[\text{Hit}] = P[\text{Correct detection}] = p_D$$

$$\therefore \alpha \downarrow \longleftrightarrow \beta \uparrow$$

neyman pearson detection:

maximize p_D for fixed false alarm
e.g. $\alpha \leq 0.05$.

BEG CuP → Cauchy pdf

"Thick tail" bell curve
(infinite variance)



$$X \sim C(m, d) : f_x(x) = \frac{1}{\pi d \left(1 + \left(\frac{x-m}{d}\right)^2\right)}$$

scale or "dispersion" $d > 0$

location: m

CDF: $F = \tan^{-1} + \frac{1}{2}$

$$F_x(x) = P(X \leq x) = \frac{1}{\pi} \tan^{-1} \left(\frac{x-m}{d} \right) + \frac{1}{2}$$

Standard Cauchy:

$$Z \sim C(0, 1) : f_z(z) = \frac{1}{\pi(1+z^2)}$$

$S\alpha S$: Symmetric Alpha-Stable pdf.

family of bell-curves: $0 < \alpha \leq 2$

$\alpha \downarrow \longrightarrow$ thicker tails

$\alpha = 2$: Gaussian

$\alpha = 1$. Cauchy

(related: Generalized Central Limit Theorem)

Bayesian Inference

Idea: Parameter Θ becomes a r.v. $\Theta \sim h(\Theta)$.

"Subjective"



"Objective"

experiment data.
likelihood: $g(x|\Theta)$

$\therefore$ Find posterior pdf $f(\Theta|x)$

Bayes theorem:

$$f(\Theta|x) = \frac{h(\Theta) \cdot g(x|\Theta)}{\int_{-\infty}^{\infty} h(\Theta) \cdot g(x|\Theta) d\Theta}$$
$$\propto h(\Theta) \cdot g(x|\Theta)$$

conjugacy: $f(\Theta|x)$ has same pdf form as $h(\Theta)$

$\therefore$ use $f(\Theta|x)$ as new prior and iterate

Thm: (Beta is conjugate to binomial)

$$\text{If } h(\theta) = \text{Beta}(\alpha, \beta)$$

- prior

$$g(x|\theta) = \text{binomial}(n, x, \theta)$$

- likelihood

(Bernoulli trials)

$$\text{then } f(\theta|x) = \text{Beta}(\alpha+x, \beta+n-x) \quad \text{- posterior.}$$

Ex: Coin flip Unknown success probability

$$\theta = P(\text{heads})$$

- assume beta prior

$$h(\theta) = \text{Beta}(\alpha, \beta)$$

- flip coin n -times

← experiment

observe x heads, $n-x$ tails.

- Conclude: $f(\theta|x) = \text{Beta}(\alpha+x, \beta+n-x)$

Prf:

$$\theta \sim h(\theta) = \text{Beta}(\alpha, \beta)$$

prior

$$= \frac{\Gamma(\alpha+\beta)}{\Gamma(\alpha)\Gamma(\beta)} \theta^{\alpha-1} (1-\theta)^{\beta-1}$$

for $0 < \theta < 1$

$$X|\theta \sim g(x|\theta)$$

likelihood

$$= \text{binomial}(n, x, \theta)$$

$$= \binom{n}{x} \theta^x (1-\theta)^{n-x}$$

$$\therefore f(\theta|x) = \frac{h(\theta) \cdot g(x|\theta)}{\int_{\theta=0}^{\theta=1} h(\theta) \cdot g(x|\theta) d\theta}$$

But: $\lim_n \int f_n \neq \int \lim_n f$ in general

$\rightarrow$ but may hold. Similarly $\lim_n \frac{d}{dx} f_n \neq \frac{d}{dx} \lim_n f_n$

Ex: $f_n(x) = n \cdot x (1-x^2)^n$ if $x \in [0, 1]$.

$$\therefore \lim_{n \rightarrow \infty} f_n(x) = 0 \quad \text{since} \quad f_\infty(0) = 0 = f_\infty(1)$$

$$\text{But: } \lim_{n \rightarrow \infty} \int_0^1 f_n(x) dx = \lim_{n \rightarrow \infty} \frac{1}{2} \cdot \frac{n}{n+1} = \frac{1}{2}.$$

$$- \sum_{n=1}^{\infty} M_n \text{ converges}$$

then $\sum_{n=1}^{\infty} f_n$ converges uniformly on S .

Thm: If power series $\sum_{n=1}^{\infty} a_n (x-x_0)^n$ has radius of convergence $R > 0$ then $\sum_{n=1}^{\infty} a_n (x-x_0)^n$ converges uniformly in every interval $|x-x_0| \leq r$ if $r < R$.

★ Chi-Square pdf

$X \sim \mathcal{X}(\frac{r}{2}, 2) = \chi^2(r)$ with "r-degrees of freedom"

$\therefore X \sim \mathcal{X}(\alpha, \Theta)$ if $\alpha = \frac{r}{2}$ & $\Theta = 2$.

Moments: (1) $E[X^k] = 2^k \cdot \frac{\Gamma(\frac{r}{2} + k)}{\Gamma(\frac{r}{2})}$ if $k > -\frac{r}{2}$.

MGF: (2) $M_X(s) = (1 - 2s)^{-r/2}$ if $s < \frac{1}{2}$

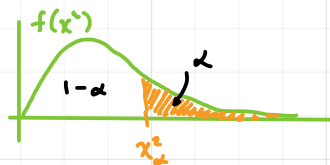

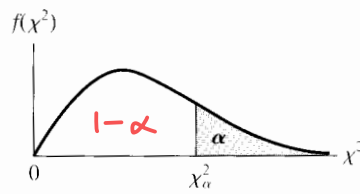
